costumes made of palm fronds. Mellifluous melodies of Christmas Carols were coming from their mouths and yet, "is that Bahasa Malaysia I am hearing?" Such was my initial confusion when I first saw the Orang Asli christian community from Gopeng perform during the state government's annual Christmas celebration a few years ago. And thus began my fascination with this indigenous group.

hristmas 2010 saw me at a Christmas service at Gopeng's Shalom Church. It was a Sunday Service on December 26 and the afternoon service was a lively affair with the congregation of Orang Asli singing carols and reciting testimonies.

For Christmas 2011, determined to meet the Orang Asli parishioners from Gopeng, I contacted the Pastor of Shalom Church, Rev. Jack Mongudai, a Sabahan, and had the pleasure of caroling with Shalom Church parishioners over two nights at Kg Pos Raya, Gopeng and Kg Ulu Jelintoh.

Ethereal Scene for Christmas Carols

The Orang Asli community at Gopeng live at 4 main villages of Kg Ulu Groh, Kg Ulu Kampar, Kg Ulu Geruntum and Kg Ulu Jelintuh. The total population at these 4 villages is over 5,000 of which 1,000 are Christians.

An evocative scene of flickering candles at Kg Pos Raya, where a parishioner had recently shifted into a low-cost house, was ethereal as the carollers sang and read by candlelight since electricity had yet to be connected. Kg Ulu Jelintoh was a kampong setting and the magic of Christmas was emanating from the Christmas carols at their homes, culminating with the entire group of carollers congregating at the Ulu Jelintoh Chapel with the rest of its Christian community for prayer followed by a fellowship pot luck meal prepared by the families there.

I had felt that my assignment would not be complete if I didn't witness a Christmas service right in the heart of Gopeng's Christian Orang Asli territory, Kg Ulu Groh where 95% of its community is Christian.

Hence, on Christmas morning I drove up to the chapel at Ulu Groh a good 15km from Gopeng town. There were over 120 parishioners in the congregation that morning, all smartly dressed, children included.

This morning was also the first time I met Reverend Eduan, a born and raised member of the Ulu Groh community, who led the chapel service that morning.

The praise and worship service as always was lively and inspiring but this time I witnessed dancing girls with tambourines in hand dancing to Christmas carols which added another dimension to the meaning of joy associated with Christmas.

Missionary District

The Gopeng Shalom Church is an Anglican denomination church which was part of St Peter's parish, Fair Park, Ipoh. The Shalom Church was opened in 1999. Fifteen years later in 2011, it was classified as a Missionary District Church and has over 2,000 parishioners. Its ministry services 17 locations bordering from Gopeng to Kg Air Denak; Tronoh to Kg Choh; Tg Rambutan, Ulu Kinta and Gua Musang (Kelantan), and its services are conducted in Bahasa Malaysia.

According to Dr Teoh Soong Kee, St Peter's Church advisor in charge of the Bahasa Malaysia Ministry, the villages of Kg Ulu Groh, Kg Ulu Geruntoh and Kg Ulu Kampar in Gopeng are the main locations where their congregation is located, and the Orang Asli Christians have been in the area for over 50 years.

Teoh could not indicate when the Orang Asli were converted but it is documented in the book Kinta Valley by Khoo Salma Nasution and Abdur-Razzaq Lubis that the "Anglo Chinese Boys School on Lahat Road was the first English school as well as the first Christian Mission School in Kinta."

The school was founded by Reverend W.E. Horley who also opened other Christian Mission Schools in Kampar, Telok Anson, Taiping and Sitiawan and also took charge of the schools in Tronoh, Tapah and Gopeng.

Home Grown Leaders

Over the last 50 years, explained Teoh, the Missionary District has produced two Orang Asli pastors, Lizune Bah Chong who was born in Kg Air Denak, Tronoh and Reverend Eduan Bah Chimpok, 42, a third generation Christian born in Kg Ulu Groh, Gopeng.

According to Eduan, his grandfather Bah Nuyop was the first Semai resident from Ulu Groh to be converted to Christianity in 1962. "At that time the missionaries were Methodist. When I was 7 years old I was sent to board at Anglo Chinese School, Kampar where I lived till I returned after Form three".

Eduan recalls that there "were around 50 Orang Asli youths at the school then from throughout the state, Teluk Anson (Teluk Intan), Sungai Siput, Tapah and Sitiawan. Besides Sunday service we participated in other activities in the youth ministry." At age eleven Eduan recalls being asked to become a pastor but he never gave it a second thought then

Eduan only considered becoming a pastor in the late nineties after a serious illness. When he recovered he decided to become a pastor and enrolled at the Malaysian Baptist Seminary, Penang where he received a Bachelor in Theology. During his nine years with the seminary he continued to serve his parishioners around Gopeng.

Eduan is now based at St Peter's Church, Ipoh and takes care of the Bahasa Malaysia speaking parishioners. "These parishioners are mostly from East Malaysia, are educated and comprised of army and police personnel and students. Our service is in Bahasa Malaysia, so we also attract Indonesians."

Eduan describes his mission work with the urban and rural community as challenging because their needs are totally different.

The rural community is generally uneducated and the service is to teach and build a foundation while the urban community is educated and requires more than the "Sunday service which was all that was available when I started in 2009. Now we provide classes for children, discipleship and theology, all in Bahasa Malaysia and I am currently training leaders to help in these Ministries."

With all these activities Eduan still has time for mission services which is currently at Sungai Siput and Chenderiang.

So my last Christmas was time well spent getting to meet another community living around the fringes of Ipoh, the smiling and friendly Orang Asli Christians of Gopeng. Gathering from the way Reverend Jack and Eduan are going about their mission services I dare say we can anticipate an increase in their community.

Taman Kaya Syndrome 🔣

would not call it as an act of desperation, but more appropriately, an inspiration. So what drives the residents of Taman Kaya to literally fence themselves in and turn their once idyllic "taman" into a garrison? Could safety be the consideration or is it the fear of the unknown? Both factors, coupled with a growing sense of despondency, compounded by the fact that the Police are too overstretched and undermanned, prompted the 65 households of Taman Kaya to do the unthinkable – keep strangers out and residents in.

Led by their Residents' Association President, Augustine Anthony, they pooled their resources and engaged a contractor to build a guardhouse on the main arterial road leading into the housing estate and sealed off all the side roads, including its southern flank, marked by a bushy no-man's land separating residents' homes from the adjacent army ammunition dump. The 65 households, plus an additional three from neighbouring Taman Perak, have now assumed an envious station in life – members of a guarded neighbourhood right smack in Ipoh Garden East.

Taman Kaya, incidentally, is not in the best of locations, tactically speaking. It is hemmed in on all sides by houses, an ill-placed ammunition dump and the lumbering North-South Expressway. Its vulnerability is being amplified by the escalating number of break-ins, robberies, snatch thefts and extortions, occurring almost on a daily basis.

"One of the residents was threatened at gun-point recently," said Augustine. "The audacity of the intruder is simply mind-blowing," he added. That was the breaking point. "We've to do something before someone gets hurt. The authorities seem powerless to act."

Augustine had led the residents through a number of face-offs with the authorities, especially Ipoh City Council and the Police. When the columbarium issue threatened to escalate into a full-blown battle between City Council and the developer, on one side and the residents, on the other, Augustine garnered enough support to force the council to reconsider its stance. Today what is left of the columbarium is an empty land overgrown with lalang, a stark reminder of an unpopular decision made in haste and in poor taste.

Ipoh Echo highlighted the plight of Taman Kaya residents who demonstrated their displeasure with the Police for their inaction in combating crimes recently. They picketed in the open and carried banners clamouring for police action. "Lawlessness is becoming a way of life for Ipohites and unless we send a clear message to those in authority, we'll be in for a tough time," said a forlorn Augustine. He seems determined to do whatever possible to correct the impropriety. "Two wrongs do not make a right," he exclaimed, alluding to the famous English proverb.

The guard house, boom gate, chain-link fences and collapsible gates cost almost RM6,000. Four men are employed to keep the taman under surveillance 24 hours a day. The guards work in pair on a 12-hour shift. Motorists are provided car stickers to indicate

their affiliation with Taman Kaya. On a lighter vein, could the name "Taman Kaya" be the reason why it is so attractive to burglars and the many unsavoury characters on the prowl? But the residents are ordinary folks with simple needs and tastes!

The 68 households pay RM60 each a month to keep their taman protected. "There was the initial resistance. But over time most began to appreciate the long-term benefits, so they acceded," said Augustine.

The basis of consideration, according to the Ministry of Housing and Local Government's guidelines, is that 51 per cent of households must agree to be guarded. "We've a situation where almost 97 per cent of the households consented," said the Ipoh-based lawyer. The overwhelming response is indicative of the residents' desire for a crime-free environment. This is the growing trend in Kuala Lumpur where guarded communities are becoming the in-thing today. Kota Damansara is a fine example. Security companies are cashing-in on the development much to the chagrin of residents. But do people have a choice?

However, a check with Ipoh City Council says otherwise. The mayor insists that Taman Kaya residents have contravened council's by-laws. "Roads and lanes in housing estates should be accessible to people and vehicles," said Mayor Dato' Roshidi Hashim. "Rubbish needs to be collected. In the event of a fire, how are firemen going to douse the flames?" Building a guard house requires a permit, he said. "The residents' association has 15 days to respond to the council's letter." Another face-off is in the offing. It is a ticking time bomb.

In The Name of My Father's Estate

fter one week of contacting all his family members, John Lee managed to arrange for a meeting between his family members and his lawyer, Dave, on Thursday morning in John's office. As Dave walked into the office conference room, John and his family members were already there waiting. Dave apologised to all as he was ten minutes late. John then continued by introducing his family members starting with his mother, Mrs Patricia Lee who is seventy five years old, his second and third brother named Nick Lee and Steven Lee aged 48 and 45 respectively, sisters Michele Lee, Nancy Lee and Sandy Lee who are aged 40, 39 and 37 respectively.



After the introduction, John asked Dave to explain. "Thanks John" said Dave. Then Dave told the family members that since Mr Lee senior died without a will, an application for the Letter of Administration (LA) is essential for the family to unlock his estate which is now frozen. Dave further explained that "to apply for this document, all the beneficiaries would first have to appoint an administrator or administrators." "Who is the administrator and what does he or she do?" asked Nick Lee. Dave replied, "Anyone of you present can be the administrator if you get the consent from all the beneficiaries of the estate and the court approves it. So in your father's case, the beneficiaries would be his wife, Mrs Patricia Lee and all his children which means all of you who are present in this room." For a few seconds, everyone was looking at each other wondering who it shall be.

Then Dave said, "the responsibility of an administrator is to make a list of all of the assets of the estate and attach it to the rest of the legal documents for submission to the High Court and once the LA has been issued by the High Court, the Administrator can then collect all the assets in the estate. Thereafter, he or she has to ensure that all the liabilities in the estate must be settled before distribution to the beneficiaries. Now, according to the Malaysian Distribution Act, 1959, Mrs Patricia Lee will be entitled to one third of the estate while six of you will share equally the remaining two thirds of the estate."

Dave also highlighted to all that after appointing the administrators they would also have to appoint two guarantors (who are sureties to provide an administration bond) for the estate so that if the administrators abscond with the estate money, the two guarantors will have to pay the beneficiaries. So, the guarantors must provide a guarantee of the gross estate value of the deceased's estate. "What if we can't find the guarantors because we ourselves may not qualify to that value" asked Sandy Lee. "I have to check on whether there is any exemption on this," replied Dave.

He continued by asking the family members to choose an administrator first. Nick Lee volunteered to be the administrator while John said it's better for him to take up this role because he is the eldest and has been helping his father manage his property company during his lifetime. Then, Sandy Lee said, "that is a separate matter. Why not we take a vote on this and decide on the appointment by a vote of majority." Michele and Nancy proposed John to be the administrator while Sandy preferred Nick. Steven was undecided and looking for his mother's decision. At this point Dave interrupted and said, "the decision must be unanimous before it goes to the courts." Then Mrs Patricia Lee said, "for heaven's sake can you all stop arguing." She then turned to Dave and said, "I think I have to speak to them privately. Can we come back to you later?" "Sure" replied Dave and then left the room accompanied by John.

World Glaucoma Week March 11 - 17, 2012

In conjunction with *World Glaucoma Week 2012*, Ipoh Echo talks to Consultant Eye Surgeon Dr S.S. Gill about this "silent thief of sight".

What is glaucoma?

Glaucoma is a group of eye diseases that result in progressive damage of the optic nerve (the "main cable" that carries visual information from the eye to the brain). If glaucoma is not treated, it permanently damages vision in the affected eye(s) and results in blindness. It is often, but not always, associated with increased pressure of the fluid in the eye (aqueous humour).

Glaucoma has been nicknamed the "silent thief of sight" Hospital Fatimah because the vision loss normally occurs gradually over a long period of time without significant symptoms until you eventually lose significant vision. In other words, it means that one will only notice poor vision when the disease is serious and the damage to the optic nerve is advanced.

Worldwide, glaucoma is the second leading cause of blindness after cataracts. Glaucoma affects one in 200 people aged fifty and younger, and one in 10 over the age of eighty. As many as 6 million people are blind in both eyes from glaucoma today. Most of these people were once unaware they had this disease until they lost significant vision in one or both eyes.

One reason why a person may not realise that he or she is losing vision

is because the vision loss involves the peripheral part of a person's vision. This peripheral vision loss is the reason why it goes unnoticed by the patient until the very late stage when the central vision starts being affected. Rarely, in some patients there may be symptoms of slight eye discomfort, mild headache and haloes around lights.

Any person who is 40 years and above should go for glaucoma screening. More so, if you have a family history of glaucoma and have never been screened for glaucoma yourself, you should go for an eye check as soon as you can.

Be Street-Smart To Stay Safe

e have all done it at some point or other in our lives: We leave home to go to work or to the shops, but before driving onto the road, leave our car unattended for a few seconds, with the engine running, to lock or close the gate.

Not all of us can afford to have electrically operated gates or are privileged enough to afford a maid who comes running to the gate to close and lock it, when alerted by the sound of the horn.

Recently, a woman who left her car for a few seconds with the engine running, turned around only to find that as she was fumbling with the lock, a man had seized the opportunity to drive off in her car.

There was little she could do except watch, stupefied. After seconds of stunned disbelief, her cries for help alerted her neighbours but by the time they came to her assistance, the opportunist carjacker was miles away.

She had not only lost her car, but her mobile phone, her handbag and her laptop which was on the front seat. A police report followed but the policeman said that her misfortune was a common occurrence. People are unaware they are being watched and unaware suspicious characters are lurking about.

Do we know who is watching?

We may think we know our neighbourhood well, but do we really know who is watching the inhabitants of the area? Are we fully aware only when we visit an unfamiliar and rough looking neighbourhood? Most of us know of at least one person, who has had a gold chain, handbag or purse, snatched, in supposedly smart areas of town.

One close colleague, a business man, had his workers' monthly wages, secreted in his briefcase. On the way to the office, he decided to go on a site visit and left the briefcase in the boot of his car. He thought this would be safe. It was something he had done several times in the past.

When he returned, the boot had been forced open, the briefcase was open and the money was missing. He was unaware that he had been trailed from the time he left the bank to collect his workers' wages. To this day, he does not know if it was an inside job or not. Sometimes, we let ourselves down with our routine.

Beware of tell-tale signs

How many times have we parked our car in a car park or by the roadside and omitted to remove items from the seat or the dashboard? Leaving the satellite navigation system in the car is stupid. Even an innocuous looking packet or plastic bag, is tempting enough for an opportunistic thief. A map would indicate that the car owner is not familiar with the area. Even a circular mark on the windscreen will tell a would-be thief that there is a

We've heard of drug addicts who remove taps to sell them for scrap. Some people have reported that shoes are removed from the front porches of their homes. Why invite trouble by leaving items in our car, in full view of others?

Simple Measures

Despite previous warnings by the police and the media, many women are

Women can prevent having their handbags being snatched or their gold chains being ripped off if they adopt a few simple measures.

A handbag kept close to the body may deter the would-be bag snatcher. But some women fail to secure the catch or zipper and in a melee, it would be so simple for someone to quietly slide a purse, from the open handbag. Necklaces should be hidden from view.

SeeFoon checks out street corners in Ipoh Garden East

poh is often touted to have more good eating places per square kilometre than most other cities in Malaysia. It is almost impossible to have a disastrous meal in Ipoh – (I know I can hear some of you protesting) – if one goes by certain rules of thumb when being adventurous and walking in to unknown restaurants to try their fare.

Without patronising the gourmands out there who read this column and who know all this, I am offering here a few tips to keep in mind for the food novices amongst you, when going to a new place. Firstly, do not walk in if the place is empty. If it is packed to capacity, it's a good sign. Secondly, as you're walking to an empty table, glance

around at all the other tables and notice what others are eating and what

looks appealing. Thirdly, ask for the head person/ boss/chef/whatever and ask for his recommendations, his signature dishes and lastly what do most of his order. customers With these tips in mind, it really is impossible to have a bad meal anywhere in Ipoh.

This is certainly the technique applied by my foodie friend Ginla Foo who brought us recently to Restoran Splendid in Ipoh Garden East. A corner restaurant on the slip road of Hala Bandar Baru Tambun, just after Citrus Restaurant, Splendid is only open at night and is packed especially on weekends when all the families are on their weekly outing.



Proprietor and chef, Soo Kok Yew, and his friendly staff will happily recommend his specialties particularly the ones on weekends which will vary from week to week.

We were there on a weekday and Ginla had ordered the menu which began with braised tofu topped with diced pork and black mushrooms. What was unusual about this particular offering was the base on which the tofu sat, which was a thin egg custard, which when scooped up with the sauce made for a creamy addition to the tofu. aksa Lemak is not as ubiquitous as its cousin, the laksa asam. One would be hard pressed to find a stall around the corner. It is more popular down south in Johor, or even further down south, in Singapore. In Ipoh, it is also known as Siamese Laksa. Although varying in preparation, the soup or gravy is always made with coconut milk (santan), hence the 'lemak' connotation. All ingredients for the fish-based soup are ground and this makes a rich and thick gravy with flavours which may include lemongrass and galangal. Bean curd puffs, fish sticks, shrimp or cockles may be added with garnishes of mint

Vietnamese mint (daun kesum), cucumber, beansprouts, or even pineapple. The Laksa is sometimes served with a spoonful of sambal chilli paste or a calamansi lime (limau kasturi).

The soup of the day was the 'Fan Got', a type of taro-like thick root vegetable boiled with pork spare ribs and chicken feet. While most of the westerners at our table shunned the chicken feet, the rest of us Orientals tucked in with gusto, leaving only the root vegetable which is usually not eaten, being terribly fibrous and used primarily to impart its special sweetness to soups. RM15 for a portion for 8 people.

The *Ham Dan chicken* was next, chunks of chicken fried crisp with the addition of salted egg yoke which was delectably palpable on the surface. The addition of curry leaves added a further piquancy – RM8/12 for S/L.

Another meat dish followed, the soya sauce/black vinegar fried spare ribs, tangy, not too cloyingly sweet and with just the right touch of vinegar. RM8/12 for S/L

Signature Prawn Curry

The next dish to arrive was one of their signature dishes, a prawn *curry* fragranced with turmeric in a thick coconut/milk based curry sauce that was very mild yet redolent with Indian flavours. Prawns at RM8 per 100g. Our dish that evening for eight people had 500g of prawns RM40.

Hard on its heels were the Assam Fish Head, pungent, sweet chunks of fish head cooked with okra and long beans. RM6 per 100g; the Ham Yu Fah Lam Po, thin slices of pork belly sautéed with onions, dried red chilli and that overriding aroma of salted fish, RM8/12 and the Eggplant fried with belacan RM7/10, all of which were scrumptious.

As we sat there in semi stupor after all the dishes had been wolfed down with alacrity, the aroma of Wat Dan Hor (smooth egg rice noodles) wafted by and we watched with longing as plates of noodles and different types of rice dishes were served to the late 'supper' crowd.

We asked for the list of noodle and rice dishes and was handed a very extensive menu with tempting items like Fried venison with dried chilli; bitter gourd chicken rice; dried chilli sour Mantis prawn rice, salted fish rice; special venison rice and sambal petai rice. We all then made a vow to return another evening to sample some of these which ranged in price from a reasonable RM3.50 for the simple noodle and rice dishes to RM8.00 for the fancier venison versions.

Ingredients A:

6 eggs – hard boiled 2 tablespoons butter

2 sandwich cheese slices grated.

Salt & pepper to taste

Ingredients B for decoration:

Small piece of carrot cut into thin triangles about $\frac{1}{2}$ inch in length – 24 pcs

1 teaspoon vinegar

1 teaspoon sugar

1/4 cup water

Salt to taste Small bunch of fresh parsley

- 1. Bring to boil the vinegar, water, salt and sugar in a small saucepan. Add the cut carrot & cook for 3 minutes (don't let it discolour). Remove from fire, cool and drain. Discard water.
- 2. Use a sharp knife and cut each egg length wise into 6 equal wedges. You should get 24 pcs. Scoop out the yolks. The whites should resemble boats.
- Use 4 yolks and add in all the ingredients A and mash to a soft creamy paste.
- 4. Scoop teaspoons of the cream and fill the egg whites or use a piping cone and pipe in the cream.
- 5. Decorate with carrot sails and a pinch of parsley leaves. Place in the refrigerator to chill before serving.

Taman Kaya Street Party

Residents of Taman Kaya, Ipoh Garden East, who recently converted their housing estate into a guarded neighbourhood held a street party literally on the street where they lived.

The party was a pot-luck party held on the 13th day of Chinese New Year and the party started with the tossing of yee sang by the women and children of the neighbourhood. Before the start of dinner residents were seen gaily walking round the neighbourhood in a manner reminiscent of a street scene at new villages in years gone by.

Taman Kaya was turned into a guarded neighbourhood on January 15 this year (see page 3 editorial). It is located at a corner of Ipoh Garden East and is bordered by the north-south highway, Taman Perak and Taman Ipoh Timur. The area is secured with four main gates and three back-lane gates. With the introduction of the guarded neighbourhood, "since 15 January there has not been a single incident of crime in the neighbourhood. Furthermore, this is the first time in 16 years where not a single crime was committed one week before Chinese New Year," trumpeted Augustine Anthony, Chairman of Taman Kaya Residents Committee.

was none other than Chief Minister,

Dato' Seri DiRaja Zambry Abd Kadir who dropped by Yong's

shack at Jalan Kuang, Buntong on Chinese New Year night. Zambry was so moved by what he saw that he immediately got Yayasan Bina Upaya Darul Ridzuan (YBU) to build Yong a new house to accommodate his family of five, which includes his aging mother, Kam Long Yong, 76.

The 3-bedrooom house will come with a kitchen, toilet and a living room. "It will definitely be more presentable than what I have now," he told Ipoh Echo when met. Yong's run-down wooden house belongs to his grandmother and was passed on to him upon her demise many years ago. "I can't afford to repair the house, as whatever I earn goes to feeding my family," he said with tears welling in his eyes. Yong makes about RM700 a month doing odd jobs in the city. "The Year of the Dragon has brought me luck," he said. "I am truly indebted to the state government for coming to my aid in my hour of need."

The Chief Minister made another stop on the same night. He visited Chai Wah Leong, 55, a bachelor who lives alone in a dilapidated hut in Ampang Baru, Ipoh. Chai is another pitiful case. He was abandoned by his family and left to fend for himself over a decade ago. "I've resigned myself to my fate," he told Ipoh Echo. Plucky Chai is determined to face adversity the best he can and considers his hardships a challenge.

Zambry ordered that a similar house be built for Chai by YBU. The one-bedroom house will be spacious enough to accommodate him and his friends should they drop by. It will have running water and electricity, amenities which are absent in Chai's wooden hut.

The houses, according to Hairul Anwar, YBU's Director of Corporate Services, will cost between RM30,000 to RM35,000, depending on specifications. They will be completed in March. Construction works are underway.

On the subject of homestay programmes in Ipoh which is currently non-existent, Hamidah has proposed to set up a programme for Ipoh. A homestay programme must consist of a choice of 10 participating homes to be recognised as such.

Changing Ipoh's Skylin

poh Mayor Dato' Roshidi Hashim has predicted that in another two years the "skyline surrounding Ipoh town will be different". He made the prediction after the monthly City Council full board meeting at the end of January.

High rise buildings in Ipoh have been restricted because the close proximity of Sultan Azlan Shah Airport to Ipoh town could affect the safety level of flight operations during take-off and landing. These restrictions are stipulated in the International Civil Aviation Act guidelines which are applied to all airports in Malaysia.

Nevertheless the Department of Civil Aviation (DCA) has provided Ipoh City Council with a map

indicating the flight path to the airport and a guideline for the maximum height of buildings.

Roshidi announced that the fringe locations of Meru Raya, Pulai, Jelapang, Chepor Tanjung and Rambutan could

allow high rise building up to 30 storeys.

DCA's guidelines state that the height of a building

was dependent upon the location and its sea level. At sea level 85.3 metres the building height is limited to 15-17 storeys while at sea level 106.7 the height is between 27-30 storeys.

According to Roshidi the construction of high-rise buildings is an important element for the development of Ipoh. Currently the highest buildings in Ipoh are the Tower Regency Hotel, 17 stories, and Kinta Heights, 20

Developers wishing to construct high-rise buildings are advised to contact the council's Town Planning Department to verify the type of building allowed.

Report Card for MBI Councillors



The swearing-in ceremony of the Ipoh City Council councillors was reported in the New Straits Times as "ENCORE: State councillors re-appointed in the hope that they would again deliver excellent results".

Dato' Dr Mah Hang Soon, state local government committee chairman, said that the state was satisfied with their work and so they were re-appointed. No survey was carried out among the residents on the performance of the councillors. What criteria did Dr Mah use to claim that all the councillors have done well?

I receive many calls from residents complaining about their problems mainly with clogged and broken drains, grass cutting and garbage. I always tell them to contact their councillor first. Many residents do not know who their councillor is. Those who know inform that it is difficult to contact the councillor and even if they do make contact, the person is too busy to attend to their problems. That is the reason they call me.

I live in Zone 8 which comprises Lim Garden, Merdeka Garden, Cherry Park and Tembok and am lucky to have Dato' Daniel Tay Kwan Hui as my councillor. He is a role model for councillors and others should emulate him. Upon being appointed as a councillor in 2009, he arranged for a meeting with the representatives of the residents at MBI during which staff of MBI were present. Daniel Tay introduced MBI staff and told the representatives to contact them if they have any problems. He divided the zone into four sub-zones and visited residents of each zone. He and MBI staff personally saw the problem areas and corrective actions were taken. Daniel Tay can be easily contacted and is willing to help.

K. Nathan, a businessman who lives in First Garden said that the residents are disappointed with the services provided by their councillor. Nathan said that in mid September last year, major drainage work was carried out at Lebuh Taman Pertama. The job was abandoned after two weeks due to technical problems. The roads were dug up and the contractor did not close the trenches he had dug. No work was done for two months and the place was flooded during rain. It was not safe to use the roads. The residents were frustrated and as a last resort Nathan contacted the Menteri Besar and requested him to help out. Finally the job was completed in about a week at the end of December. The residents feel that the councillor had failed in his duties for not taking action.

When contacted, Liew See Fan, councillor for First Garden said that he is familiar with the project which was to upgrade the drains to prevent flooding. He knew that the work was stopped due to technical problems faced with underground water pipes and electrical cables. However, he was not aware that the contractor did not cover up the trenches and fill up the pot holes which were his responsibility. He was in fact discussing with the engineering department at MBI about how to solve the problem as quickly as possible. He regrets that the residents were not informed of the problem. He added that residents can always contact him for assistance.

In Penang several civil societies organised a Know Your Councillor campaign, whose purpose was to enable Penangites to judge for themselves whether their councillors were up to the mark. The councillors were given a questionnaire which required them to list three of their major achievements for last year and to give three of their main goals for this year if they were re-appointed and reason for re-appointment.


When I googled "report card for local councillors", I found that many local councils in other countries assess the performance of their councillors annually. Their grades are available online with their achievements and failures.

Councillors are seen by rate-payers as the first line of access to the local government. They are expected to serve the interests of the ratepayers. As such, there should be more checks and balances and they must decide without fear or favour in the decisions of the committees they sit on. They have to decide what is in the public interest amidst a range of conflicting issues and views. They must work to improve the quality of life for the people and meet regularly with residents' committee members.

It is time for NGOs in Ipoh to come together and carry out a similar survey. Let the residents judge the performance of the councillors.

BOOK REVIEW

Selvamany More than a Teacher


This is a biography of a teacher with a great heart. His mission in life was to teach as best as he could and to be always there for his students. As a teacher, he was able to inspire, discipline and motivate his students towards success. He cared for his students, their studies, their welfare, their health and their families. He also fortified them with universal good values.

Many students whom he taught in Anderson School Ipoh, as well as Sekolah Menengah Idris Shah and Sekolah Menengah Seri Teja, Gopeng, and others who had the chance of being associated with him, feel so grateful for having been given the opportunity of knowing him and learning from him.

This biography was produced with the intention of recording for posterity and sharing with others the goodness of humanity in Dato' Seri N.S. Selvamany.

The biography starts by tracing his "roots and routes" and describing how Selvamany's great grandparents left Pondicherry, India, to seek their fortune in Malaya in the late 19th Century. It then relates how and why Selvamany became a teacher after his tertiary education at Raffles College, Singapore. His teaching career started in Anderson School Ipoh from 1952 to 1972 and then on to Sekolah Menengah Idris Shah, as its Principal from 1972 to 1979 and as Principal of Sekolah Menengah Seri Teja, from January 1980 to January 1981 when he retired. The book documented how Selvamany was being bestowed with honorific awards such as the Tokoh Guru Negeri and Kebangsaan in 1996 and 1997 respectively and several state awards in 1995, 1997, 2008 and 2009. However, his "most treasured asset" and reward has always been his family, extended family, former students and friends whom he considers as his "sons and daughters".

Although Selvamany has long retired from active service, he continues helping the underprivileged, especially children; living up to his motto "Serve man, serve God". He keeps in touch with his former students, occupants at the various charitable societies



and homes as well as friends and acquaintances at all levels of society. His reminder would be, "This is my life" and that is the way he likes to live it.

The lead writer, Dr Rokiah Talib, was from the Form 6 class of 1962/63, ASI and a former Professor of Anthropology and Sociology, University of Malaya. The biography project was undertaken by an Organising Committee under the chairmanship of Tan Sri Nuraizah Hamid. The biography was launched by DYMM Sultan Azlan Muhibbuddin Shah on January 15, 2012 at the Royal Chulan Hotel, Kuala Lumpur.

Almost every feature of the launch programme was provided by former students of Selvamany – the funds needed, the reception and editorial team, the "Andersonians Forever" choir and the accompanying music, the emcee and even the Ustaz who recited the *doa selamat*. It was the former students' way of saying "To Sir, with Love".

The biography is not for sale. However, it is available privately at a nominal donation of RM50 per copy. This donation will help to defray printing costs and postage. The Organising Committee certainly appreciates
