


Fast Track and Emotional Healing Technique (EFT)

Fast track technique and EFT is another healing modality that helps a person to enjoy better health and general wellbeing. In this method, muscle testing is used to access the subconscious mind and locate the root cause of a particular issue that is contributing to the imbalance in your life, whether it be physical or emotional.

It was a delight to spend time with Jaz Goven, a British national who has been conducting training sessions here in Ipoh, as she took me through the very simple stages of her programme.

Muscle Testing

According to Jaz, your body will always tell you the truth when your subconscious mind is questioned. And muscle Lee Jee Wai testing is the key to accessing the subconscious mind. Once accessed she continues to probe for the root causes



Jaz is passionate about helping people help themselves, which is an attractive feature of the technique, if you don't want to keep seeking "treatment" on a regular basis. Jaz hopes that by learning the fast track technique and EFT, any individual will be able to, not only address their emotions and overcome negativity, but will also be in better control of their health and their lives.

TCM (Traditional Chinese Medicine) and Acupuncture

As far back as 4000 years ago, people have been turning to TCM and acupuncture to treat all kinds of ailments. Today it is enjoying a revitalised popularity as more people are discovering its efficacy.

Queenie Kong took some time away from her busy schedule to explain just how TCM and acupuncture helps. Practising her art of healing since 2008, she bases her treatments on finding the root cause of the problem rather than simply treating the symptom. This, Queenie emphasizes, is the only way to keep the negative condition from recurring.

Queenie uses four different "checking steps" to determine the root cause of any negative condition, before attempting to treat her clients. Observing, Listening, Questioning and Palpations make up the check list. She then examines the condition of your tongue to further confirm her initial diagnosis. A standard session could take anywhere from 20 to 45 minutes, while the more intense sessions take an hour during which time she may prescribe acupuncture to relieve symptoms or she may make up a herbal mixture for you to decoct at home or even give you herbal medicines in capsule

Another interesting area that Queenie's expertise covers is Aesthetics acupuncture. The 'before' and 'after' pictures of ladies having 'gone under the needle' on their faces for firming and de-wrinkling were so spectacular that even a skeptic like me found myself tempted. So ladies, you might want to consider this before going under the knife, to make those all so 'little' adjustments.

Karmic and Angelic Reiki

Another Reiki practitioner I had the pleasure of meeting, was Lee Jee Wai. Using Angel therapy cards was part of Lee's foray into the world of alternative healing. He is passionate about making people understand that their general well-being is intricately connected to their physical, mental, emotional and spiritual balance. With his attunement to Reiki and healing sessions, Lee hopes to help individuals seeking help to finally achieve that all so important balance in their lives.

Lee's work is heavily based on the Forgiveness Principle, which is the Hawaiian Teaching of "Ho o Pono Pono". The words mean "I am sorry, Please forgive me, I love you and Thank you". These words are usually uttered at the beginning of the Reiki session to allow some of the negative energy from within to be released and replaced

with positive energy. The inner peace often enjoyed, usually works as the ideal launching pad for the individual to pursue Reiki further.



ssociating Ipoh with pomelos, taugeh and cheap hawker food comes easy, as these products are readily available for visitors and travellers alike. That is, however, the positive side but we have a negative side too, one which has been nagging us for a while now. It is our over-publicised but under-utilised airport. The city's one time pride and joy is today a pale shadow of what it was in the 1960s right to the 1990s. Blame it on the North-South Expressway for redefining land travel.

Sultan Azlan Shah Airport has undergone several structural and cosmetic changes involving its facade and its image. The latest being the extension of its runway from 1.8 km to 2 km. Although claims of impropriety have surfaced regarding the exact length of the runway, it did not stop airlines from using the airport.

Among the more notable one was AirAsia. The hype surrounding its introductory Ipoh-Johor Bahru flight was one of a kind. The whole city came to a standstill when Tony Fernandes came to town with his team in February 2006. Lesser known airlines came along, some lasting a few months, some weeks and some with hardly anything to show, save for their banners and buntings adorning the airport walls. They came with a bang but left with a whimper. That was the sad truth. Today, the only company that uses the terminal is Firefly, a subsidiary of our flag carrier MAS, operating the lucrative Ipoh-Singapore-Ipoh route daily.

Countless representations were made to the authorities, including the highest office of the state but to no avail. Most Ipohites, including this scribe, have lost hope of ever seeing the city's airport being transformed into a regional transport hub of standing like Penang's Bayan Lepas Airport or Alor Star's Sultan Abdul Halim Airport.

But things are about to change now that a local company has decided to take the plunge. Flying Fox Airways, a joint venture between Ipoh-based Mega Dynasty Sdn Bhd and Indonesia's third largest carrier, Sriwijaya Air will fly the Ipoh-Medan route beginning November 8. The twice weekly flights will increase in frequency once economies of scale and a credible critical mass are achieved.

Notwithstanding glitches dogging previous attempts at reviving the Ipoh-Medan route, the seriousness shown by the parties involved during the airways' launching on Friday, October 11 at Impiana Hotel, Ipoh was laudable.

The biggest handicap faced by enterprising individuals and companies in the past was aircraft. Cost is prohibitive and not having a sizeable passenger load to offset operational costs put paid to their lofty dreams. One cannot operate with leased planes, as the price of keeping the planes in flight is impossible with a poor passenger load and

So, what have we to offer people from Medan?

Health tourism is a major consideration as Medanese, due to substandard medical service in their backyard, have turned to the private hospitals of Singapore, Kuala Lumpur and Penang to seek affordable treatment for their ailments.

Ipoh's five private hospitals should optimise this opportunity to the fullest. They should take a leaf from Penang's Adventist Hospital. The services provided by this Pulau Tikus facility extend beyond healthcare. They include meeting their clients at the airport, making hotel reservations, taking care of family members (sightseeing and shopping), transportation and others. It is a very competitive business and those who walk the

extra mile get the customers. It is all about marketing one's services, not hard selling that many here prefer to do.

Ipoh's hawker food is a hit with foreigners and Medanese are no exception. Indigenous food (Minang, Sunda, Betawi, Batak, Padang, etc.) in Medan is very good but Chinese cuisine is not. Indian is almost non-existent. Western-type outlets in Medan are better than Ipoh. A food fest, held on a quarterly or half-yearly basis, will be a good start to promote Ipoh's gastronomical delights.

Education is another major consideration. Ipoh's three international schools have ample space for children from Northern Sumatra. With the availability of direct flights to Ipoh, Indonesian parents will be tempted to send their children over. Our rates are a lot cheaper than either Singapore or Kuala Lumpur, and this is a fact.

Since the rich Chinese community in Medan is our primary target, winning them over becomes a priority. We should get enough Hokkien-speaking minders to take care of these visitors. A 4-star hotel in Pulau Tikus, Penang employs Hokkien-speaking staff to cater for this specific need, and it is reaping results.

So it is up to those in the private sector to up the ante. It will be a sin to allow another golden opportunity slip by unnoticed.

EYE HEALTH - INFLAMED EYELIDS

Ipoh Echo's EYE HEALTH series continues with Consultant **Ëye Surgeon Dr S.S. Gill talking to us about BLEPHARITIS, or** inflammation of the eyelids.

epharitis, or "inflammation of the eyelids", comes from the Greek word "blepharos", which means "eyelid" and "itis" which means inflammation.

WHAT DOES BLEPHARITIS APPEAR LIKE?

The eyelids usually appear crusted, red and swollen. The crust is yellowish-white and powdery, like the scalp of a person who suffers from dandruff. There may be varied symptoms. In most cases, the eyes become itchy, irritated and sometimes feel dry due to the disruption of the layer of tear film that is normally present in the eye. Contact lens wearers may complain of discomfort and a gritty sensation. This is often mistaken by the layman as "dry eyes"



When blepharitis becomes chronic, there may not be much signs of inflammation such as redness but just a visible crusting on the eyelid and eyelashes. This may appear a little unsightly especially when the crusting on the eyelashes is visible. You may liken it to a skin condition except that in the case of blepharitis, it affects the eyelid margins where the eyelashes arise. Blepharitis can affect any age, both young and

WHAT CAUSES BLEPHARITIS?

When the oil glands at the eyelid margins malfunction and produces too much oil (sebaceous secretions), blepharitis can occur. At times, it may be associated with an underlying skin condition called Acne rosacea where there is already a generalised illness of the oil glands of the skin. Allergies to certain cosmetics like mascara, eyelid lotions, contact lens solutions, allergens in the air and some chemicals may also trigger *blepharitis*.



WHAT ARE THE COMPLICATIONS OF BLEPHARITIS?

Blepharitis usually does not cause any serious eye conditions. However, it may cause the following:

This occurs when the oil glands of the eye gets infected. A lump appears on the eyelid margin in a localised area. There may be some pus seen on the tip of the ye (appearing like a pimple about to rupture), with surrounding redness of the eyelid.

2. Chronic Conjunctivitis:

Blepharitis may cause recurrent bouts of conjunctivitis or pink eye. If this happens, eliminating this underlying problem is essential.

Occurs when the oil glands of the eyelid get blocked. This is painless but appears unsightly with a lump appearing on the eyelid.

Due to chronic irritation by the inflamed eyelids and/or a misdirected eyelash growth, an ulcer may form on the cornea. Corneal ulcers are serious conditions.

HOW IS THIS PREVENTED AND TREATED?

Good eyelid hygiene is essential to prevent *blepharitis*. Frequent face washing, warm compresses over the eyelids and removal of eye makeup is important. Remove any crusting present on the eyelid margins. Cleaning the eyelids with a cotton bud soaked in a very dilute (5 parts water to) baby shampoo is helpful to control any excessive oiliness and crust. Basically, every effort must be made to keep the eyelid clean. The other alternative is to use a special over-the-counter Lid Care cleaner. Keep the eyes closed when cleaning. Be especially careful to avoid rubbing or scratching your eyes.

If you are in doubt about any eyelid problems, do seek professional help.

Boy Has Lucky Escape

ohd Amar Mohd Aziz, a ten-year-old primary schoolboy from Sekolah Kebangsaan Belanga, in Parit had a lucky escape after being shot by a police sergeant on Monday October 14.

The incident happened around 4.30pm at Kampung Belanja Kiri when the policeman alleged that whilst cleaning his pistol in front of his in-laws' house, a bullet was negligently discharged from the Walther P99 automatic, and hit Amar who was playing about 50 metres away.

The bullet entered beside Amar's nose, and stopped at the back of his skull, near the bones at the nape of the neck (the cervical vertebrae). He was "lucky" because the bullet missed his spinal cord and the major blood vessels in the neck, by one centimetre.

Despite his injury, Amar was able to run home and alert members of his family to seek help. They first took him to a clinic in Parit, then the Batu Gajah Hospital where he was transferred to the Ipoh General Hospital. At the paediatric intensive care unit, he waited for specialists to

operate and remove the bullet.

Hospital neurosurgeon Dr Cheang Chee Keong said that movement could damage the vital structures that were near the bullet and said that if Amar's spinal cord had been hit, he could have been paralysed and damage to his voice box would have made him mute.

Hospital director, Dr Raja Lope Ahmad said that members of his medical team were in constant discussion with Amar's family to advise them on the best option with the least risk.

On the morning of October 20, six days after the shooting incident, a team of six specialists took two hours to remove the bullet lodged in Amar's neck. His relieved father, Mohd Azizi Abdullah said that on regaining consciousness, his son had asked for a glass of water. He said, "I am so glad that the doctors managed to conduct the operation and that my son is in a stable condition now."

As a temporary precaution, Amar was placed in a neck brace as his neck bone had cracked from the impact of the bullet. Dr Cheang said that doctors would re-examine his neck after two months to see if further surgery was necessary, to stabilise his neck.

Amar may be on the road to recovery, but attention soon focused on the circumstances leading to the shooting. Initial reports indicate that the police sergeant was cleaning his weapon when it was fired. He was a deputy investigating officer with the Taiping police headquarters and he was on leave.

Deputy Superintendent of Police (DSP) Leong Ah Kow said that the pistol and a magazine with 14 rounds of ammunition, which were seized after the incident, would help investigations, under Section 39 of the Firearms Act 1960. The policeman involved was detained, to assist with enquiries.

Angry citizens have expressed their outrage and concern about the incident and asked if the incident was a case of negligence, reckless abandon or bravado, by the policeman.

One man said, "Why did the policeman not surrender his gun, when he was on leave? Are there no Standard Operating Procedures (SOP)?" Another said, "If the policeman was negligent, then his superiors are also negligent. Both should be charged with dereliction of their duties."

A former member of the armed forces said, "Safety procedures must be strictly adhered to. Safety is everyone's responsibility. Investigations should include his superiors, not just the suspect."

A former policewoman said, "Disciplinary action should be taken against those who neglected their duties in ensuring strict adherence to SOP and the monitoring of firearms movement. This incident gives an insight into the missing firearms highlighted by the Auditor-General's report."


One cynic said, "I would not be surprised if there is no further action (NFA) in this case. After all, the Home Minister advocated a policy of "Shoot first, ask questions later". Someone else said, "If there's a blame, then there's a claim."

The NGO, Suara Rakyat Malaysia (Suaram) has recommended that the policeman should be suspended, whilst Dr Kok Chin Leong, the president of the Malaysian Paediatric Association said that a review of existing firearms laws and the enforcement of more stringent protocols and SOPs of firearms are necessary.

The investigation into the shooting is ongoing. Initial news reports claimed that doctors had been informed that the child was hit by a bullet which ricocheted off the ground; however, witnesses allege that the shot had been fired in Amar's direction. Moreover, a police source said that X-rays were not consistent with a bullet which had been deformed by striking the ground.

Perak police chief Acryl Sani Abdullah Sani said, "We changed our angle of investigation after taking statements from witnesses. The policeman was on leave during the incident and we want to know why he was carrying his weapon when he wasn't on duty."

Indicating that the "straight-forward, non-complicated and non-tricky case" would soon be closed, he assured the public that the investigations would be conducted with transparency, and that the deputy public prosecutor's office would receive their report. He did not want the public to think that policemen were unprofessional and behaving like they were not fully trained.

What is a Newborn Baby's Job?

"Life is really simple but we insist on making it so complicated." — Confucius

Babies lead a simple life. They eat, sleep and fill the nappy. This is their job. However for young parents it can be very daunting. Caring for a newborn baby is a full time job thus understanding the needs of the newborn makes their care less complicated. In this article, we look at the feeding of a newborn baby.



Newborn babies can be breastfed and/or formula fed. Breast milk is the ideal form of nutrition for babies. Breast milk is the perfect food for a human baby's digestive system. It contains the vitamins and minerals that a newborn requires, and all of its components – lactose, protein and fat are easily digested by a newborn's immature system.

Breastfeeding requires a substantial commitment from a mother. It also meets a variety of emotional needs for the mother and baby. It burns calories and helps shrink the uterus, so nursing mothers get back in shape quicker.

Maternal health both physical and mental health, is key to successful breastfeeding. Mothers, need to be calm and relaxed. It is important they eat a healthy diet, drink plenty of fluids and rest as much as possible.

During the first few days after delivery, mothers produce **colostrum**, thick and yellowish or thin and watery. Colostrum contains antibodies that help protect infants from a wide variety of infectious diseases



After about 3 to 4 days of nursing, the breasts will start to feel less soft and more firm as milk is

produced. The milk supply is determined by the stimulation the body receives. The more one breastfeeds, the more milk the body produces. If possible, nursing is started straight after delivery or within an hour after the birth. This timing takes advantage of the newborn's wakefulness as they will spend the rest of the day sleeping. If the mother is unwell or has had caesarean section this may not be possible.

It s important that that baby latches with a wide-open mouth and takes as much as possible of the mother's areola (the dark-coloured area of the breast) in his or her mouth (not just the tip of the nipple). Mothers may need support in getting babies to latch onto them. This may come from the elders in the family or the midwife who has attended the delivery. In some institutions they have a lactation consultant that advises mothers on breastfeeding.

Sometimes, mothers with inverted nipples have difficulty with feeding. Mothers should avoid using pacifiers and bottles as these are known to cause "nipple confusion" and the baby may give up on breastfeeding.

When one is breastfeeding, one can't measure the amount of milk the baby drinks during each feeding. If the baby is having four to six wet nappies per day and gaining weight then the baby is getting enough.

Sometimes, mothers are unable to breastfeed as they may be unwell, had a difficult delivery or a caesarean section. In these instances, babies are fed with formula milk till the mother is well enough to breastfeed. Finally, it is the choice of the mother whether she wants to breastfeed or formula feed her baby.

"A newborn baby has only three demands. They are warmth in the arms of its mother, food from her breasts, and security in the knowledge of her presence. Breastfeeding satisfies all three." — Grantly Dick-Read

The twelve pork-free stalls have enough variety to suit everyone's palate. From soup noodles to baked cheese rice, western snack food, nasi ayam and ayam percik, rojak and traditional fare like laksa, rendang and Chinese popiah made in



different ways and chee cheong *fun*, one is spoilt for choice.

Mee Bakso (RM4), an Indonesian beef noodle soup which comes with beef balls and beef patties or beef balls and slivers of beef. Mee Bakso Gabung - RM6 Get it from 'Aneka Sup'. The familiar Sizzling

Mee from the old food court sells for RM5.50 plus 50 sen extra with an egg. A must-try is the Udon Mee (RM7.50) from 'K Seven Delicious'

'Ikan Bakar Kampung' serves ikan pari and ikan kembong baked in tin foil with ladies fingers and limau kasturi. This 'Selera Sutera

Thai' also has Nasi Goreng Thai (RM5.80) with lovely crispy ikan bilis on the side.

For western and snack food lovers, 'KJ Fusion' has a Jumbo Hotdog on their menu and Cheese Baked Rice with chicken/fish (RM11.90) amongst other things, while 'Pak Tuan Meatball' has **Roti John** (RM7) with meatballs in a hotdog bun

There are numerous rice dishes starting with the usual chicken rice from the 'Nasi Ayam' stall and also Nasi Ayam Percik (RM5.80) from 'Ayam Percik'

The **Rendang** from 'Rendang Tok Mak Nik' is a must-try and the **Asam Laksa** Taiping from 'Taiping Delicious'.

poh Parade, one of Ipoh's largest shopping mall destinations, has been undergoing a series of renovations lately, and we are pleased to reveal that one of its recently completed phases has been its brand new, swanky food court. Named the Next Food Avenue, this food destination

Plus dishes are very affordably priced as the ambience and cleanliness of Next Food Avenue is a class above other local food courts.

Non-halal Food Court



- Hakka Yam Abacus (RM6) from 'Noah Hakka Food' stall. Other






Back part of the food court:

Corporate Trustee The Ultimate Protection

It is said that life insurance is like a parachute. Therefore, many breadwinners of urban families in Malaysia have bought life insurance to protect their families from the many uncertainties of life.

Ironically, before the Insurance Act 1996 was replaced by the Financial Services Act 2013, many life insurance policy holders have appointed themselves as trustees of their own policies.

This didn't make sense at all, as to file a life insurance claim, the policyholder has to either be suffering from a critical illness, is senile, in a coma, permanently disabled, or dead. How good is a trustee if he or she was in such a condition as described above?

Under this new Act, which came into effect on July 1, policyholders can no longer name themselves as the trustee to their own life policies. This applies to new policies but existing policies may be affected as well should the policyholder die without making proper back up plans.

During a talk held at a leading hotel in Ipoh recently, Saw Leong Aun, Group Managing Director of Rockwills Corp Sdn Bhd, explained to participants the potential risks involved in relation to this change. He described at length, Schedule 10 of the Financial Services Act 2013 and its implications on policyholders.

The potential risks include the inability of the surviving spouse to manage a large sum of money, the spouse remarrying before the children reached the legal age of 18, or even death of the spouse who is the automatic trustee, if there was no proper appointment made.

What if the individual trustee was biased, or if there was a special-needs beneficiary

involved?

In cases like these, the purpose of taking out life insurance is defeated, as the insurance monies may not go to the persons the policyholder had intended it to go to, or it could even be held by the public trustee, Amanah Raya Bhd.

Saw also explained the differences between a direct nomination and licensed corporate trustee, and how assigning the policy to a corporate trustee is the ultimate protection for life insurance money.

Major advantages of an insurance trust are naming of substitute beneficiaries, instructions to distribute insurance funds periodically, and customised payment

schedule for each individual beneficiary to prevent squandering or being conned by others.

While the onus is on responsible insurance agents or estate planners to explain

While the onus is on responsible insurance agents or estate planners to explain this new policy to their clients, those who are holding a life insurance policy and have appointed him or herself as trustee of the policy are advised to make the necessary changes to comply with the new rule and protect their insurance monies.

Flving Fox Airways

new airline will take off from Sultan Azlan Shah Airport this November. Flying Fox Airways, the first airline to register in Perak, was launched in early October by State Exco for Tourism, Culture and Health, Nolee Ashilin Mohd Radzi. Also present at the launch was UPEN Director Dato' Abu Bakar and Flying Fox CEO Danial Lee.

Nolee in her address stated that the introduction of this new airline would see an increase not just in tourism but international trade and investment. "I welcome the airline with open arms and for opening a route through Ipoh to Medan and Dhaka. We hope to explore an alternative route to China via Medan."

Noting that there were three travel agents and an airport authority from Medan present at the launch, Nolee expressed the hope of "tapping more into the Medan market especially for medical tourism".

Flying Fox Airways' maiden flight will touch down at the Sultan Azlan Shah Airport



on Friday November 8 and its destination will be to Medan. For November there will be two flights per week to Medan on Monday and Friday. Subsequently in December the flight frequency to Medan will be increased to four times per week and will also introduce an Ipoh-Medan-Dhaka, Bangladesh route.

According to CEO Danial Lee, Flying Fox Airways is a code



sharing partnership with Sriwijaya Air of Indonesia, one of Indonesia's leading airlines. The airline will use Boeing 737-400 aircraft with a seating capacity of 152 passengers. Flights into Medan will touchdown at the newly-opened Kuala Namu Airport.

The airlines tagline 'Flying Just Got Easier' reflects the convenience for Ipohites to use the Sultan Azlan Shah Airport, explaining the ease of going from home to the airport as compared to having to travel to KLIA.

Lee added, "The Medan flight is just the beginning. The long-term plan is to increase flight frequency to daily and to expand to international destinations like Thailand, China and Japan. We are currently working with tour agencies in Medan and Ipoh to develop packages and promotions for Ipoh to China, Thailand and Japan".

During the launch, representatives from the private hospitals were present. Nicholas Chan, Senior Manager Business Development with Pantai Hospital acknowledged that there was plenty of potential to grow the scope of medical tourism. "We can't expect to grow overnight but initiating a regular direct flight to Medan is the first step towards maturing the medical tourism market in Ipoh."

Individual tickets are also available.

SI Ipoh is a branch of Soroptimist International, a worldwide organisation for women in management and the professions working through service projects to assist underprivileged women and children.

Projects they have undertaken include training and organising single mothers to do housecleaning work for income; facilitating full day seminars to train school counselors on child sexual abuse. They have so far covered six districts in Perak, reaching about 500 schools and benefitting close to 100,000 school students from this *OK Tak Ok* informational seminar. Other projects involve medical health camps; a road survival programme on how to stay safe on the road from accidents, road bullies, con artists and many more; and raising awareness on "Stop violence against women".

The just concluded gathering of poets from around the world for the 33rd World Congress of Poets (WCP) was an astounding success. The grand closing ceremony held at Pangkor Island on Friday night October 25 was witnessed by close to 2000 VIPs, participants and islanders.

The week-long event was organized by the World Academy of Arts and Culture (WAAC) in collaboration with Institute Darul Ridzuan and the Perak State government. It was attended by close to 300 poets from around the world including Malaysia.

Raja Muda of Perak Raja Dr Nazrin Shah officiated at the closing ceremony. He was accompanied by Raja Puan Besar Tuanku Zara Salim. Other VIPs present at the event included Perak Menteri Besar Dato Seri DiRaja Dr Zambry Abdul Kadir accompanied by his wife Datin Seri Safripah Zulkifli, Nolee Ashilin Dato' Mohammed Radzi (Executive Councillor for Tourism, Health and Culture), Perak-born WCP President Mdm Wan Hua Chapoutier and Maurus Young, WAAC President.

Before the close, participating poets from China and Mexico presented their poems. Perakean, Mdm Chapoutier recited her Sungai (River) which won an award at the 29th WCP in Budapest, Hungary in 2009.

Perak MB Zambry, who originated from Pangkor Island recited his poem dedicated to "Ayah (My Father)" with verses "You are a fisherman of noble deeds, You are a father whose love is enthroned, You are a husband with words so courteous" which touched the audience.

During the congress the visitors were taken to Perak's popular tourist destinations where they held poetry recitals. The locations covered included the Lenggong Archeological Museum as well as Ipoh's Heritage Trail and Gua Tempurung before concluding at Pangkor Island.

The poets described their visit here in superlative terms such as China poet, Bei Ta, who described the Congress as "more wonderful than he had expected". Describing the role of the WCP as to improve communications between the foreign countries and the host, he was pleased to note the participation of so many local poets.

very beautiful". Describing the locations visited, Turczi summarized that "Perak is a metaphor, everything is close together and in one place, in your heart."

The success of this global event would not have been possible if not for the initiative of Perakean, Mdm Wan Hua Chapoutier nee Goh who had approached Zambry way back in 2011 requesting to hold this congress in Perak. Her initial purpose was to introduce the world of poets to Ipoh's blue hills and delicious kopitiams.

Mdm WanHua, who worked with the Office of The Permanent Delegation of Malaysia to UNESCO in Paris for thirty five years, stated her objectives to have the congress in Malaysia was to "promote Bahasa Malaysia as the future lingua franca for the region and also to introduce pantun as a medium to expose local poets to the

The deciding factor to select Ipoh and Perak was that Zambry was a poet and the choice for Perak to host the 33rd WCP was sealed.

For Zambry's contribution to poetry in the state he was appointed the Honorary Patron of the 33rd WCP and awarded the "Crane Summit Supreme Honor Crown Medal Award", the WAAC's highest award in appreciation and recognition of the contribution of leaders in the field of poetry.

Held in conjunction with the closing ceremony was the handing over to Peru, the host of the 34th World Congress of Poets.

As for Mexicans Solsis and Soberanis, who originally referred to Malaysia as the Twin Towers, now on departure for home, they will inform their friends to visit the Twin Towers and visit Perak too. Now that's a successful event indeed.

City Hall Dreams

The Mayor of Ipoh City Hall must have the right facts before blaming and insulting residents for the filthy state of this city because there is evidence that these problems are due to neglect by City Hall.

During the past decade, residents have brought to the attention of City Hall the same problems they encounter daily. But for unknown reasons City Hall failed to upgrade the inefficient and inadequate essential services and allowed the state of the city to deteriorate. The easiest way out is to blame the residents and make broken promises of a cleaner city.

Recently, the Mayor mischievously stated he was unable to clean the city because residents could not be disciplined and refrained from throwing rubbish indiscriminately.

One of the important duties of the Mayor is the maintenance of cleanliness. He is held responsible and accountable if he fails to perform this task with commitment. All problems pertaining to cleanliness must be solved and not swept under the carpet. Is it so difficult to find solutions to these problems? If he had investigated and analysed the thousands of reports lodged, the results would indicate most of these problems are created by his own staff, particularly the "illegal dumps". This is to remind the Mayor of the assurance made on September 2012 of a cleaner Ipoh by the end of this year. After 13 months and a new management programme implemented, this assurance is another failure and as usual it is the fault of the residents. To cover up this failure and distract the attention of the residents, there are now plans to transform Ipoh into a sustainable and dynamic city by 2020, another mission impossible.

Despite failing to clean up the city for the Visit Perak Year 2012, the Mayor has again embarked on an impossible mission, grooming the city to regain its reputation as the cleanest in the country, ahead of Visit Malaysia 2014. The Mayor must be realistic. It is far beyond the capability of City Hall to achieve this target. He had admitted of not being able to clean the city because of indiscriminate dumping.

At present, drains in residential areas are cleaned once every few months and the large amount of rubbish are not collected for weeks or left permanently to rot on the road sides. The monthly collection of garden and other bulky rubbish is never on schedule and residents are forced to dump this rubbish wherever convenient. More dumps appear as the interval between each collection gets longer.

The trash collectors are also responsible for the illegal dumps. They are seen on their motorcycles heaping the bagged rubbish for collection by the dumpster. Spilled and damaged bags at these collection points are not their responsibility and soon become mini dumps.

Street sweeping in residential areas is no longer a service given by City Hall. Littering in the commercial areas will continue because there are very few litter bins. Pedestrians continue to lose rights as more businesses boldly display their wares on the pavement. The wet markets are just as dirty and congested. There is lax enforcement of law and order.

With such poor quality services, is it possible to maintain the city in an orderly and clean state? The four members of the state assembly and two members of parliament elected by the residents on promises to look after their interests have remained silent over the huge problem. City Councillors without executive powers, rely on the same lackadaisical MBI officers to resolve the similar complaints brought to their attention by residents. There were no zoning duties when the city was clean.

The mayor's vision of a cleaner city was hampered by the lack of support and coordination from his senior officers and an inefficient workforce. Until such time that MBI is able to improve its services to a satisfactory level, City Hall should be very careful if it intends to blame the residents. The city would have been in a worse state if residents failed to cooperate. The state of the city is not solely due to littering but lack of commitment to develop Ipoh into an orderly spic and span city.

If City Hall is serious in cleaning up the city, it should cease all activities which does not benefit the residents. Set up a board of inquiry and take appropriate disciplinary action against all those who are responsible for this dirty state of the city.

Meanwhile, residents must wait patiently for the appointment of a Mayor of action and not words, to untangle the mess at City Hall.

KLIA Express Cannot Impose Itself on Consumers

hen I go from KL to Medan I usually check in at KL Sentral then take the train to KLIA. I must have done it a hundred times. But on my last trip I decided to exert my right as a consumer.

I have always thought that one is free to choose one's means of getting to KLIA. However, in the past 99 times I have decided to overlook KLIA Express' implied condition that only they be used. This time I did not (overlook their imposition), and instead challenged it.

KLIA Express has positioned its ticket counter right at the access to the check-in counters giving the impression that only by buying their train ticket can one pass through the barrier.

On this occasion the gate was opened and I passed through without being stopped. I duly checked in my luggage but as I exited the barrier was shut. An officer from KLIA Express asked me how I got in. I told him. He was furious that I had checked in my luggage without buying a ticket first.

I told him that it was not a condition of my airline ticket that I should use KLIA Express which made him even more furious. He insisted that it was but was unable to back up his claim. I told him I could travel by KL Transit if I wanted to, to which he asked if I was over 55 (what a compliment!). What has that got to do with the price of fish I wondered

Nevertheless, it was a climb down from his original position. I then made it clear to the small gathering that consumers have a choice how they travel to KLIA. One can go by bus which is only RM8 or be taken there by a friend, or go by KL Transit and save RM10 if one were a pensioner.

It is the deceit and arrogance of KLIA Express that if one wanted the convenience of checking in at KL Sentral, one had to use them that I find unacceptable. MAS and Cathay Pacific operate the city check-in for the convenience of their passengers not for the profit of KLIA Express.

I suggest that the electronic gates be removed so that passengers will not be fooled into thinking that only by buying a KLIA Express ticket can they check in.

There may be occasions when I may decide to use them but that is my choice as a consumer. It is unacceptable that consumers must give in to this kind of monopoly.

They say we are wrong to cut our trees to plant oil palms

ver a period of a few decades around 1850, 95 per cent of the two million acres of Redwood forest in California were cut and destroyed. What kind of men would cut down these ancient irreplaceable giant trees? Each of them was over one thousand

Oil palm smallholdings and plantations meet the United Nation's Framework Convention on Climate Change which defines a forest as an area of 0.5 to one hectare having more than 30 per cent canopy cover and having a potential height of two to five metres. To accuse the industry in Malaysia and Indonesia of contributing to global warming is sheer nonsense. In fact oil palm trees just as with other forest species, produce oxygen for us to breathe and act to counter coal and oil emissions which are the major cause of global warming.

Environmental activist groups such as World Wildlife Fund, Friends of the Earth and Greenpeace have launched many campaigns alleging that the expansion of oil palm plantations have destroyed forests, threatened endangered wildlife and robbed indigenous people of their land. Many of their arguments are not based on fact but are sensationalized from a small number of cases.

The anti-oil palm lobby in the west includes pro-soya bean and rapeseed groups who see oil palm as a major competitor and have recruited food lobbyists to play on fears of the health hazards of palm oil consumption. Together with environmental activists, these well-funded groups have created trade barriers to the global oil palm trade under the pretext of environmental activism.

In a fair contest amongst competing vegetable oils, palm oil will win hands down. The oil palm tree is the world's most efficient oil crop because one can harvest five tonnes of oil per hectare. This is 10 times more productive than soya bean planted in the West, including United States and five times more productive than rapeseed, Europe's main oil crop.

It is an undeniable fact that palm oil is the cheapest and most popular form of cooking oil for consumers, including many poor families in the west. Should trade barriers to benefit rapeseed farmers who are already heavily subsidised by the European Union (EU) government be successfully implemented, this will hurt consumers all over the world.

Also should alternatives to oil palm be grown, more land would be needed to produce an equivalent volume of oil to replace palm oil, resulting in more deforestation and problems for Mother Earth.

Finally, the western environmental activists' campaign against oil palm plantation expansion, in the name of "saving rainforests", is a violation of international norms and Malaysia's and Indonesia's sovereignty.



State-of-the-Art Cancer Centre Now Fully Operational

r Chan Wee Han has been in his element since the opening of the *Wolfgang Cancer Centre* in Fatimah Hospital. Oncologist Dr Chan says, "Its been over four months since the official opening of *Wolfgang Cancer Centre* and almost two years since I first started providing cancer treatment in Fatimah Hospital. Thankfully, all our facilities and services are up and running smoothly."

"Our new building which houses the Elekta Synergy Linear Accelerator with 160 Leaf Multi Leaf Collimator (Agility), has been treating patients with Volumetric Modulated Arc Therapy (VMAT) since March this year. Used mostly in complex Head and Neck cancers, this state of the art radiation therapy delivers precise radiation in 360 degree arcs around the patient. It is also used in Prostate, Rectal, Gynaecological and Brain cancers as well.



Moreover, since April this year, we have been treating gynaecological cancers such as Cancer of Cervix and Uterus with 3-Dimensional Conformal Brachytherapy. Since then, local patients with gynaecological cancers no longer need to travel out of Perak for their treatment.

"With the backing of a strong team of medical physicists and therapeutic radiographers, our radiotherapy services has seen steady growth. We make sure every patient goes through a patient education session with regards to their treatment procedures and care prior to starting treatment. Caregivers too are welcomed into these sessions."

Its not just the equipment that is impressive. The new *Wolfgang Cancer Centre* also houses a Chemotherapy Daycare Centre which has a waiting lounge for family members and a counselling room. Patients spend between 30 minutes up till 8 hours in leather recliner sofas or beds while having their chemotherapy infusions. Understanding the frustrations of such long hours and stress, warm meals and drinks are provided but patients can also opt to bring their own food. Astro

TV channels are provided for both patients and their waiting family.

It is here that patients and families have the most interaction among themselves and the nursing staff.

"In fact, our trained oncology nurses often carry out patient education, counselling or simply providing support to alleviate their fears and anxieties. Patients are usually from a diverse group of cancers ranging from Breast, Colorectal, Lung or Gynaecological cancers to rarer types such as Melanomas or Sarcomas," added Dr Chan.

Recently, the centre organized a "Look Good, Feel Good" session for cancer patients which provided them with guidance on makeup, wigs and breast prostheses. Some are cancer survivors which Dr Chan hopes can also help share their experiences with the newer patients. "In fact, many came with food making it a "Potluck" event. It was a good experience and we hope to be able to have more of these events in the future," enthused Dr Chan.

Knowing the importance of nutritional support, the centre has also arranged for an audio-visual presentation from one of the leading nutritional companies last month. This helped both their patients and staff to better understand the benefits and preparation of their products. There are also patients who are referred to the hospital's dietician for dietary advice.
